



## COOPERATION AGREEMENT

hereinafter referred to as "AGREEMENT"

The following contract is the agreement between with For Health Sp. z o.o [Ltd.] with its registered office in Warsaw (address: Świętokrzyska 30 lok. 63, 00-116 Warsaw, Poland) entered into the National Court Register under KRS no. 0000468954, NIP [VAT reference No.]: 5252559324, REGON no. 146780720,, hereinafter referred to as "FOR HEALTH" and a member of the NANOBEAUTY Community acting as a natural person, hereinafter referred to as the "PARTNER".

1. The subject of this Agreement is to determine the terms of the Partner's cooperation with FOR HEALTH in relation to the paid services rendered by the Partner for promotional and marketing services to FOR HEALTH, whose purpose is to increase sales of FOR HEALTH products. PARTNER provides FOR HEALTH with promotional and marketing services consisting in acquiring new FOR HEALTH customers and increasing demand for FOR HEALTH products.
2. At the same time, the PARTNER as a member of the NANOBEAUTY Community undertakes to obey the "NANOBEAUTY COMMUNITY CODE" and the "TERMS AND CONDITIONS" as annexes to this Agreement. The regulations of Terms and Conditions may be change. The Partner is required to comply with the current Terms and Conditions and the Community Code, legal regulations and to take care of the good name of FOR HEALTH.
3. The Partner is obligated to use only marketing and advertising materials provided by FOR-HEALTH only. Any materials not originating from FOR HEALTH which the Partner intends to use for the performance of the Agreement will require written approval from FOR HEALTH.
4. The Partner will receive from FOR HEALTH a commission fee based on the rules set out in the NANOBEAUTY CODE for promotional and marketing services.
5. FOR HEALTH may terminate this Agreement for the causes mentioned in the Terms and Services. Termination requires written form.
6. The right to receive a commission ends on the day of termination of the Agreement.
7. The Partner may terminate this Agreement at any time without notice. Denunciation requires written form.
8. The agreement comes into force at the moment of its acceptance by the Partner and marking it with the tag when registering on the website [www.nanobeauty.eu](http://www.nanobeauty.eu). The date of acceptance the Agreement and acceptance of the Partner to the NANOBEAUTY Community is confirmed electronically
9. The Partner also agrees to receive advertising and marketing information from FOR-HEALTH, including electronic communications.
10. The Partner consents to the collection and processing by FOR HEALTH of the personal data and image provided by the Consultant in order to execute the Agreement and for marketing purposes.
11. The transfer of rights and obligations under this Agreement requires the written consent of FOR HEALTH.
12. In matters not regulated in the Agreement, the provisions of the Civil Code shall apply.
13. Disputes relating to the Agreement will be resolved by a common court competent for the FOR HEALTH registered office.
14. In case of a conflict between the Agreement and the NANOBEAUTY Community Regulations, the provisions of this Agreement shall prevail.
